## How it Works

# 1

### Determine the type of training needed for your company

- The program is designed to consider the needs of employers and the skills required for their employees and company to be successful. ACCES will work with you to refine training options for your employees.

# 2

### Identify the employee(s) you would like to train

- Individuals must be residents of Ontario, Canadian citizens, permanent residents or protected persons. Unemployed individuals must be sponsored by an employer (through a permanent or conditional offer of employment).

# 3

### Identify training opportunities

- Training must not exceed one year and must be provided by Colleges of applied arts and technology; Publicly assisted universities; School boards; Private trainers operating in compliance with the Private Career Colleges Act, 2005 or Union-based training centres.

# 4

### Cost-sharing for the training

- Employers can get up to \$10 000 in government support per person for training costs
- Employers with 100 or more employees need to contribute 1/2 of the training costs
- Small employers with less than 100 employees need to contribute 1/6 of the training costs
